Monthly report – 31 August 2023

CastlePE's net asset value increased by 1.2 per cent during August. The monthly investment result was mainly guided by valuation increases throughout the portfolio, namely the write-up in the valuation of Viola Ventures III and SAIF Partners III. The positive investment performance was further improved by the 1.6 per cent increase in the value of the Euro versus the Dollar during the month.

August's cash flows were favourable: CastlePE received distributions of around USD 2.6 million and there were no investment level outflows during the month. Uncalled capital ended the month at USD 40.6 million or 47.3 per cent of net asset value.


NAV by investment stage as at 31 August 2023

Uncalled commitments (% of NAV)


